- One (1) year relevant work experience preferred;
- Experience in providing assistance to the poverty population, including experience in interviewing clients;
- Knowledge of immigration, family, housing and/or government benefits law;
- Self-motivated, takes initiative, ability to learn quickly;
- Excellent written and verbal communication skills;
- Ability to be flexible in job duties;
- Organized, with ability to work on high-volume caseload;
- Comfortable with case management systems and other technology; and
- Bilingual in an Asian language required.

- Interview and counsel clients;
- Provide limited service to clients;
- Respond to requests for assistance submitted via telephone, online intake, and walk-in applications;
- Work in conjunction with staff attorneys in cases that involve immigration, family, housing and/or government benefits law and other legal issues;
- Work effectively as part of a team that includes attorneys, support staff, volunteers, and students;
- Participate in clinics and other community outreach projects; and
