#### **About Us**

Legal First Responders<sub>SM</sub> is a statewide program run by the Disaster Legal Assistance Collaborative (DLAC) that keeps a corps of volunteer attorneys trained and ready to respond in the immediate aftermath of a disaster

#### The Need

Legal issues can occur weeks, months or even years after a disaster. Many disaster survivors are not aware that their issues are in fact legal issues that can be resolved with an attorney. We currently need attorneys to respond to the recent California wildfires and the COVID-19 pandemic.

Other Possible Volunteer Opportunities (dependant on COVID-19 restrictions)

- Staffing a legal table at a centralized Disaster Resource Center (alongside Red Cross, FEMA, United Way, food bank, etc.)
- Staffing a disaster-related clinic located at a legal services or social services provider (Some clinics will cover many areas of law, while others may be focused on FEMA appeals or insurance issues.)
- Handling a pro bono case (e.g. eviction case, FEMA appeal, insurance litigation, etc.) for a survivor of a disaster.
- Serving as an expert mentor to other volunteers serving survivors of a disaster

#### Who am I volunteering for?

Pro bono attorneys with the Legal First
Responderssm Corps will be volunteering
with the Disaster Legal Assistance
Collaborative, and not with just one legal
services provider. Malpractice insurance
will be provided by Legal Access Alameda,
but volunteers may be directed to various
clinics or hotlines run by other agencies.
Disaster response is by necessity a
regional effort, and not limited to one
program or another.

#### What if I have conflicts?

Attorneys unable to help in a particular area of law due to conflicts can skip that training; we can ensure that you do not have to help clients with that subject area.

## Disaster Legal Assistance Collaborative

#### Who We Are

DLAC is a coalition of law firms and organizations all throughout California whose goal is to provide free legal assistance to those impacted by disasters and COVID-19 in California.

#### **What We Do**

DLAC's free legal services help folks that have been impacted by a disaster, like an earthquake or a wildfire. Through DLAC's free legal assistance programs, folks can get free legal advice, resources, and referrals from a volunteer attorney.

#### What are DLAC's services?

DLAC offers free legal help through two platforms: California Free Legal Answers and the Disaster Hotline.

California Free Legal Answers is an online platform where you can submit your legal question and get a written answer from a volunteer attorney. You just open an account, submit your question, and log in later to view the attorney's response.

On the Disaster Hotline, you can call 888-382-3406 to speak to a volunteer attorney for free.

In 2021, from January to September, Free Legal Answers helped 1,236 people with legal advice, resources and referrals.
